1. Accreditation

Accreditation for Teams & Officials and parking cards will be handed out to all Teams at the Team Captains' Meeting Thursday 29 November 2018 at Scandic Lillehammer Hotel.

2. Information Office – Lillehammer OC

The Information Office opens Monday 26 November 14:00.
Daily opening hours 07:00/08:00 – 19:00/20:00

3. Race Office

Located in Lysgaardsbakkene Ski Jumping Hill (outrun)

Thursday 08:00-16:00
Friday 09:00-19:00
Saturday 12:00-21:00
Sunday 07:30-15:00

(The Race Office will be open as long as there is activity in the Ski jumping hill.)

4. Waxing facilities

You will find the waxing cabins close to the Ski Jumping Hill - according to FIS rules.

The wax cabins will be available from **Tuesday 27 Nov 08:00.**

Key pic up: In the elevator building in the Ski Jumping hill in the outrun.

A deposit of Euro 50 must be paid to receive your cabin key.

The Hill staff will be present in the SJ Hill on Tuesday and Wednesday from 08 :00 – 16 :00.

5. Accommodation

Booking of accommodation is according to the **FIS Rules via FIS Online registration system.**

The OC offers the following accommodation with full board for the Ski Jumping Ladies Teams:

The OC will send hotel confirmations to all Teams after receiving the FIS entry by name.

Accommodation costs :

- The OC will pay for all persons within the quota according to FIS Rules.
- Price per person outside the quota and outside the competition period :
 - Single room/breakfast : NOK 990 per person per night
 - Double room/breakfast : NOK 1 390 per room per night
 - Price lunch : NOK 175 - Price Dinner : NOK 250
- The costs for additional accommodation must be paid to the OC in the OC Finance Office at the Scandic Lillehammer Hotel after during the weekend.

All TD, TDA, Judges, FIS and other guests will be accommodated at Scandic Lillehammer.
The Team Captains Meetings will be located at the Scandic Lillehammer Hotel.

6. Transport

Official airport : Oslo Airport Gardermoen

The organising committee will provide transport between the airport and the hotel. 1 transport (from and to the airport) is free of charge. Price for additional transport : 30€ per person from Oslo airport to Lillehammer (one way).

The organising committee will provide transport between the Scandic Victoria Hotel and the Lysgårdsbakken Ski Jumping Hill and return.

7. Payment

Accommodation costs : The OC will pay for persons within the quota according to FIS Rules.

To cover the Team's cost for persons outside the quota and outside the race period, the OC Finance Office will collect the money at the Scandic Lillehammer Hotel

Carrying costs/Reimbursement and Prize money :

- Payment will be handed out in the OC Finance Office at Scandic Lillehammer Hotel
- All payment will be done by bank transfer

8. Prize Money and taxes

Income tax information for prize money:

- Income tax of European citizen is 15%
- Income tax of non-European citizen is 15% (USA 0 %)
- Tax will be deducted by the OC according to the Norwegian Foreign Artist Taxation Act, and taxes will be paid by the OC according to the regular tax legislation in Norway.

9. Regulations of radio equipment :

The import, export and the operation of radio equipment in Norway is regulated by national law. Permits for the use of radiotransmission equipment must be requested according to national specifications. Information : www.npt.no

10. Visa Regulations
